Dear Mr. Gallagher:

Enclosed are your North Dakota Grain Storage Warehouse Licenses and relevant documents. Your licenses and each of the colored posters must be displayed at your facilities in an area easily visible by patrons.

State law requires that licensees submit monthly reports within 30 days of the end of each month. The grain movement numbers will be retained as follows: Forman – **7919**, Gwinner – **2529**, Havana - **2739**. This number must be used on all monthly report forms which are available on the Commission's website at <http://psc.nd.gov/forms/grain/grain-movement-and-storage-report.pdf> or the forms can be filed electronically at <http://www.ugpti.org/grain/>.

Legislation makes the information contained in these reports **CONFIDENTIAL**. Information on individual licensees cannot be released to non-governmental entities without the permission of the licensee.
