NOTICE OF PUBLIC HEARING PROPOSED ZONING ORDINANCE AMENDMENT JULY 18, 2011

Please take notice, that the Hazen Planning and Zoning Commission will conduct a public hearing on Monday July 18, 2011 4:30 pm (CDT) at Hazen City Hall for the purposes of hearing objections on a proposed amendment to the City of Hazen Zoning Ordinance.

The proposed amendment would amend the Residential and Manufactured Home District regulations to allow detached accessory buildings up to 1,600 square feet in size with up to 10 foot side-walls. Currently detached accessory buildings are limited to 1,200 square feet with 9 foot side-walls.

NOTICE OF BLASTING SCHEDULE

As required by Public Law 95-87, part 816.64 of the Office of Surface Mining Reclamation and Enforcement, Chapter 38-14.1 of the North Dakota Century Code, and Article 69-05.2-17-03 of the North Dakota Administrative Code, notice is given of a blasting schedule for The Coteau Properties Company's Freedom Mine located seven miles north and three miles west of Beulah, North Dakota.

Blasting may occur any day between sunrise and sunset starting July 20, 2011. Mine access ramps will be posted with blast warning signs. All accesses to the area where blasting is in progress will be blocked. Nearby public roads may be blocked briefly during blasting operations for safety.

Blast warning signals are: A) an intermittent signal for a preblast notification, and B) a steady signal for all clear notification.

Blasting may occur at other times during emergency situations: where rain, lightning, atmospheric conditions, or operator or public safety requires unscheduled detonation.
