



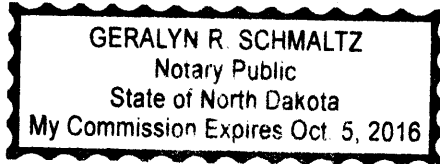

The Commission orders:



The SE ¼ of the SW ¼ of Section 17, Twp 140N, R 61W, Barnes County, North Dakota.


