


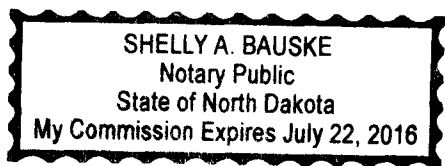

**ORDER REINSTATING WAREHOUSE LICENSE**

**August 10, 2011**

Earth Harvest Mills, Inc. dba Dakota Prairie Organic Flour Company operates a licensed public grain warehouse at Harvey, North Dakota, under license number 1155, issued by the Public Service Commission under the provisions of North Dakota Century Code Chapter 60-02.

On June 6, 2011, the Commission was notified that the grain insurance policy issued to Earth Harvest Mills, Inc. dba Dakota Prairie Organic Flour Company would be cancelled on August 5, 2011. As provided in North Dakota Century Code § 60-02-35.1, the company's warehouse license was suspended effective July 7, 2011, for failing to file proof of new or renewed insurance at least thirty days before cancellation of the current insurance filing.

Earth Harvest Mills, Inc. dba Dakota Prairie Organic Flour Company had until August 5, 2011, to procure and file proof of new or renewed insurance or submit a written request for hearing. On August 1, 2011, the Commission received proof that a replacement insurance policy had been issued to Earth Harvest Mills, Inc. dba Dakota Prairie Organic Flour Company.


**Order**

The insurance requirements have now been met and the Commission orders that:

1. Warehouse license number 1155 issued to Earth Harvest Mills, Inc. dba Dakota Prairie Organic Flour Company is reinstated, effective August 1, 2011, and
2. Earth Harvest Mills, Inc. dba Dakota Prairie Organic Flour Company is authorized to operate a public grain warehouse at Harvey as governed by North Dakota Century Code Chapter 60-02.
