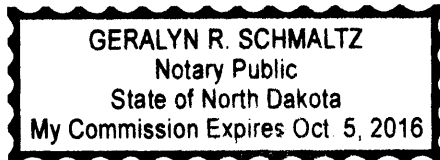

The NW ¼ of Section 9, Twp. 150N, R 66W, Eddy County, North Dakota.


