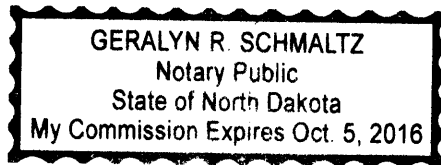

NOTICE OF OPPORTUNITY FOR HEARING

On December 14, 2011, Otter Tail Power Company, an electric public utility, filed an application under Chapter 49-03, N.D.C.C. to extend service to David Gulland at a location in Cass County, North Dakota.
