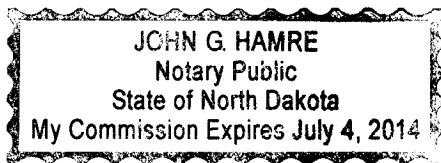

NOTICE OF OPPORTUNITY FOR HEARING

October 12, 2011

On September 13, 2011 Otter Tail Power Company, an electric public utility, filed an application under Chapter 49-03, N.D.C.C. to extend service to Dakota Midland Grain at a location in McHenry County, North Dakota.
