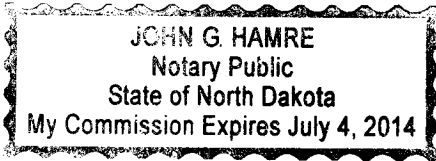

Submitted with the application was a statement by Verizon Wireless that the customer desires electric service to be provided by the applicant. Service is to be provided at a point located in:


**The SE ¼ of the SE ¼ of Section 21, Twp. 157N, R 95W,
