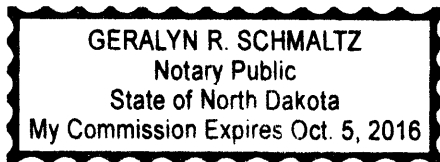

NOTICE OF OPPORTUNITY FOR HEARING

On October 21, 2011, Montana-Dakota Utilities Co., an electric public utility, filed an application under Chapter 49-03, N.D.C.C. to extend service to Oasis Petroleum at a location in Mountrail County, North Dakota.


