

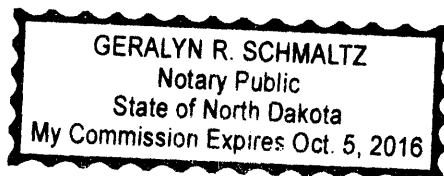

**The NE ¼ of Section 4, Twp. 143N, R 55W, Cass County, North Dakota.**


