
On May 4, 2012, Tracy Vigness Kolb, of the firm of Zuger Kirmis & Smith, filed a Motion for Admission *Pro Hac Vice* of Rjay J. Brunkow, and Affidavit of Rjay J. Brunkow, with the Public Service Commission. Mr. Brunkow seeks admission to practice *pro hac vice* in North Dakota, representing the Turtle Mountain Band of Chippewa Indians ("Tribe"), before the Public Service Commission in matter of the Complaint of North Central Electric Cooperative, Inc. v. Otter Tail Power Company, Case No. PU-11-701. Administrative Law Judge Allen C. Hoberg has been designated to preside as procedural hearing officer in the matter, and was requested to rule on Ms. Vigness Kolb's motion. The administrative law judge has reviewed Ms. Vigness Kolb's motion and Mr. Brunkow's affidavit and finds that Mr. Brunkow has met the requirements of the North Dakota Supreme Court Admission to Practice Rule 3 for admission *pro hac vice* to practice in North Dakota before the Public Service Commission in Case No. PU-11-701. Accordingly, Ms. Vigness Kolb's motion is **granted** and it is **ordered** that Rjay J. Brunkow may practice in North Dakota before the Public Service Commission, representing the Tribe, in Case No. PU-11-701.

Mr. Brunkow shall further comply with the requirements of North Dakota Supreme Court Admission to Practice Rule 3 during the course of his representation in Case No. PU-11-701.
