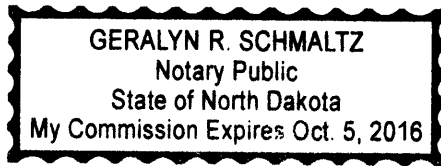

NOTICE OF OPPORTUNITY FOR HEARING

On January 10, 2012 Otter Tail Power Company, an electric public utility, filed an application under Chapter 49-03, N.D.C.C. to extend service to Curwood Seefeldt at a location in LaMoure County, North Dakota.

Submitted with the application was a statement by Curwood Seefeldt that the customer desires electric service to be provided by the applicant. Service is to be provided at a point located in:
