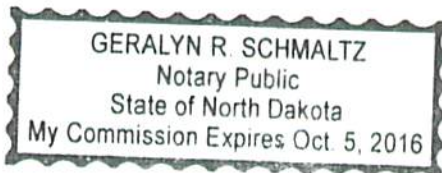


On March 21, 2012 the Commission suspended BEK's proposed switched access price schedule, Case No. PU-12-104.
