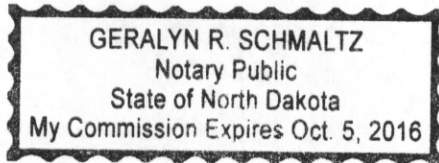





Section 28, Twp. 156N, R 91W, Mountrail County, North Dakota.


