PLEASE TAKE NOTICE that on April 9, 2012, the EAST CENTRAL JUDICIAL DISTRICT executed an Order that was duly filed in the above proceeding on April 10, 2012, appointing the Public Service Commission to act as trustee of a trust fund to be established and administered in accordance with North Dakota Century Code Chapter 60-04 and establishing the date of insolvency as February 15, 2012.


**FURTHER, PLEASE TAKE NOTICE THAT:**

1. Any person having a claim against Anderson Seed Co., Inc. for the non-payment of grain purchased or marketed by Anderson Seed Co., Inc. in North Dakota, shall file the claim with the Public Service Commission, 600 East Boulevard Avenue, Department 408, Bismarck, North Dakota 58505-0480.
2. Claims must be filed within forty-five (45) days after the last publication of this notice.
3. Any person filing a claim with the Public Service Commission shall include receipts or other sufficient documentation to enable the Commission to determine

the validity of the claim. This could include unsatisfied grain warehouse receipts, scale tickets, checks, or other memoranda given by the public warehouseman for, or evidence of, the receipt, storage, or sale of grain, or any related contracts.

4. Unless a claim is filed with the Public Service Commission within the time specified, the claimant may be barred from participation in the trust fund.
