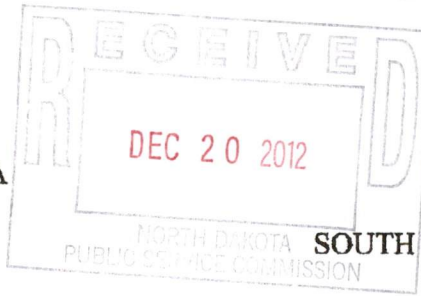

MONEY JUDGMENT

The Court has reviewed the filings herein, and granted the Plaintiff's Motion for Summary Judgment by its Order for Summary Judgment, dated December 5, 2012, finding that the Plaintiff is entitled to the entry of a Judgment against the Defendant, and issued its Order for Entry of Judgment, dated the 14<sup>th</sup> day of December, 2012.

NOW THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the Plaintiff has a Money Judgment against the Defendant, as follows:

1. A Money Judgment in the amount of \$189,878.08 (One Hundred Eighty-nine thousand Eight Hundred Seventy-eight and 08/100 Dollars).
2. Plus interest at the lawful rate of 6 1/2% per annum from and after December 15, 2011, and thereafter, until paid.
3. Plus Plaintiff's costs and disbursements herein, Sheriff's service \$35.00, filing fee \$80, and statutory costs of \$10, for a total of \$125.00.
4. For a total Money Judgment in the amount of \$190,003.08 (One Hundred Ninety Thousand Three and 08/100 Dollars), plus interest at the rate of 6 1/2% per annum on the amount of \$189,878.08 (One Hundred Eighty-nine thousand Eight Hundred Seventy-eight and 08/100 Dollars) from and after December 15, 2011, and thereafter, until paid.
