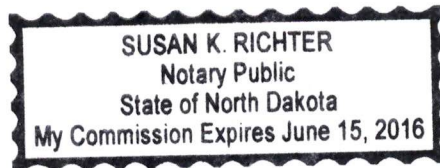

1. The North Dakota Public Service Commission (Commission), as Trustee of the trust fund provided by North Dakota Century Code section 60-04-03 for the purpose of marshalling all trust assets of Anderson Seed Co., Inc., an insolvent grain warehouse, seeks an order Approving the Settlement, Approving the Report and Recommendation of Trustee, Requiring Deposit of Bond Proceeds, Approving Payment, and Discharging Trustee. The Commission has the authority to bring this Motion and the Court has the power to grant the relief requested under North Dakota Century Code sections 60-04-03 and 60-04-07.
2. North Dakota Century Code section 60-02-09 requires that a bond must be filed with the Commission before any license can be issued to any public

warehouseman in North Dakota. The bond is for the purpose of protecting the holders of outstanding receipts and for covering the costs incurred by the Commission in the administration of the licensee's insolvency. North Dakota Century Code section 60-02-09. The insolvent licensee, Anderson Seed Co., Inc., had such a bond, issued by Auto-Owners Insurance Company, P.O. Box 30660, Lansing, Michigan, 48908-8160, as surety.

3. The Commission has reviewed claims filed against the warehouseman and detailed determination regarding the validity of each claim is attached to and summarized in the Report and Recommendation of Trustee. The proceeds from the bond will be needed to redeem outstanding receipts issued by Anderson Seed Co., Inc., as provided in North Dakota Century Code section 60-04-09. The Court has jurisdiction under North Dakota Century Code section 60-04-03.3 to order the deposit of bond proceeds.
4. The trust fund is made up of proceeds from the sale of grain and bond proceeds. North Dakota Century Code section 60-02-25.1 provides that grain contained in a warehouse is subject to a first priority lien in favor of the outstanding receipt holders. On January 13, 2012, Anderson Seed Co., Inc. entered into a Purchase Order and Security Agreement to sell a significant amount of sunflower seeds. The Commission, acting as Trustee, investigated the possibility of initiating litigation against Anderson Seed Co., Inc., the owners of Anderson Seed Co. and the purchaser. The Commission, after considering the potential claims, potential defenses and evaluating the risks of litigation has agreed to resolve all of the potential claims for a payment of \$685,000. The resolution resolves all potential

claims that may be asserted by the Commission against the parties listed in this paragraph and is not an admission of liability by any of the potential parties. The Commission has included within the settlement agreement a provision that allows the settlement to be set aside if it is determined that there has not been an accurate disclosure of net worth by Anderson Seed Co., Inc. and/or the owners of Anderson Seed Co., Inc.

5. Under North Dakota Century Code section 60-04-03.1 the "trust fund shall be established for the benefit of noncredit-sale receipt holders of the insolvent warehouseman and to pay the costs incurred by the commission in the administration of this chapter. . . ." The credit-sale contract indemnity fund was created for the purpose of providing protection for persons selling grain to a North Dakota licensed warehouse. North Dakota Century Code section 60-10-02. A person is eligible to receive payment from the credit-sale contract indemnity fund if the warehouse licensed under North Dakota law to which the person sold grain becomes insolvent and has not fully compensated the person in accordance with the credit-sale contract. North Dakota Century Code section 60-10-04.
6. Proceeds from the credit-sale contract indemnity fund will be needed to meet the licensee's obligations to holders of credit-sale contracts. North Dakota Century Code section 60-10-05 provides:

Upon the insolvency of a licensed warehouse or grain buyer and a declaration that the public service commission serve as the trustee, the public service commission shall make the proceeds of the credit-sale contract indemnity fund available for use in meeting the licensee's obligations with respect to the reimbursement of any person who sold grain to the licensee under a credit-sale contract and who was not fully compensated in accordance with the contract.

7. Under North Dakota Century Code section 60-10-06, the amount payable to any eligible person from the credit-sale contract indemnity fund may not exceed the lesser of eighty percent of the amount owed to that eligible person under that person's unsatisfied credit-sale contracts or two hundred eighty thousand dollars.
8. North Dakota Century Code section 60-04-09 provides in part:

Following hearing, the court shall approve or modify the report and issue an order directing payment of the necessary bond proceeds, distribution of the trust fund, and discharge of the commission from its trust.
9. We respectfully request that the Court approve the Settlement and the Report and Recommendation of Trustee, require deposit of the bond proceeds, authorize distribution of bond proceeds to valid cash claimants and credit-sale contract indemnity fund payments to valid credit-sale claimants and following payment to claimants, discharge the Commission as Trustee.

REPORT AND
RECOMMENDATION
OF TRUSTEE

1. The North Dakota Public Service Commission (Commission) as Trustee, makes the following Report and Recommendation to the Court:
2. Anderson Seed Co., Inc., a Minnesota Corporation, authorized to do business in North Dakota, operated grain warehouses at Durbin and Selz, North Dakota, licensed under North Dakota Century Code Chapters 60-02 and 60-04.
3. Anderson Seed Co., Inc. operated its grain warehouse at Durbin, North Dakota under license number 1132 and its grain warehouse at Selz, North Dakota under license number 1153.
4. As part of the licensing process, Anderson Seed Co., Inc. filed a bond with the Commission as required by North Dakota Century Code section 60-02-09, in the amount of \$280,000 and identified as number 087708 66042403, with Auto-

Owners Insurance Company, P.O. Box 30660, Lansing, Michigan, 48909-8160, as surety.

5. On February 15, 2012, Douglas Doll on behalf of the Doll & Pazdernik Partnership of Mandan, North Dakota filed with the Commission a letter for collection of outstanding funds owed by Anderson Seed Co., Inc. Subsequently, eighteen parties filed letters for collection of outstanding funds owed.
6. On February 16, 2012, Timothy Erdmann, Commission grain warehouse inspector, stopped at the Durbin grain warehouse and confirmed there was minimal grain inventory of unknown quality in the Durbin facility. On February 23, 2012, Mr. Erdmann stopped at the Selz grain warehouse and confirmed there was no grain inventory in the Selz facility. The station manager at Selz told Mr. Erdmann that in January 2012, all grain inventory at Selz was moved to Minnesota.
7. On February 29, 2012, the Commission filed an Application for Appointment as Trustee and for Ex Parte Order in District Court, County of Cass, East Central Judicial District.
8. On March 20, 2012, the District Court ordered that Anderson Seed Co., Inc. is prohibited from selling, transferring, removing, or otherwise compromising potential assets of the trust fund until the court issues its order granting or denying the application for appointment of the Commission as Trustee of the trust fund. On March 28, 2012, a copy of the Notice of Entry of Order with attached copy of the executed Ex Parte Order to Preserve Trust Assets was served on the parties and also sent by regular mail to thirty five persons the

Commission identified from the records of Anderson Seed Co., Inc as potential claimants in the insolvency proceeding.

9. On April 9, 2012, the District Court ordered that the Commission is appointed Trustee of the trust fund provided by North Dakota Century Code Chapter 60-04 for the purpose of marshaling all trust assets of the insolvent Anderson Seed Co., Inc. and further ordered that the date of insolvency be established as February 15, 2012, the date that the first claim for collection of outstanding funds owed for grain was filed. On April 12, 2012, a copy of the Notice of Entry of Order Appointing Trustee with attached copy of the executed Order Appointing Trustee and a copy of the Notice of Appointment as Trustee and Notice to File Claims was served on the parties by certified mail and also sent by regular mail to the surety and forty-two persons or their attorneys that the Commission identified as potential claimants in the insolvency proceeding. The notice required the filing of claims with the Commission within forth-five days of the second publication of the notice.
10. The Notice of Appointment as Trustee and Notice to File Claims was published as a legal publication in the Pierce County Tribune on April 21, 2012 and April 28, 2012 and in The Fargo Forum on April 23, 2012 and April 30, 2012, as provided in North Dakota Century Code section 60-04-03.3. The Pierce County Tribune is located in Pierce County and is the official county newspaper of the county in which the Selz warehouse is located. The Fargo Forum is located in Cass County and is the official county newspaper of the county in which the Durbin warehouse is located.

11. On August 30, 2012, the Court issued an Order for a Rule 16 Scheduling Conference scheduling the conference for October 23, 2012. The conference was held as scheduled.
12. On October 23, 2012, the Court executed a Rule 16 Order establishing the deadlines in the case.
13. On November 15, 2012 the Court executed an Order for Final Pretrial Conference, scheduling a pretrial conference for June 2, 2013 and Notice of Trial, scheduling a Jury Trial on this matter for July 9, 2013 through July 12, 2013, if necessary, at the Cass County Courthouse in Fargo, North Dakota.
14. On December 13, 2012, the Court executed an Order to Allow Joinder ordering that Auto Owners Insurance Company be joined as a Defendant, pursuant to North Dakota Century Code section 60-04-03.3.
15. Fifty-six claims totaling \$4,107,414.49 were filed with the Commission, as shown below. Additional detail on the claims provided in Exhibits A, B, C, D and E to the Affidavit of Tim Erdmann are attached to this report.

16. Only minimal grain assets existed in the warehouse at Durbin, North Dakota at the time of insolvency. The Commission liquidated the grain assets in the warehouse, with a value of approximately \$2,150, and deposited the proceeds in the trust fund.
17. North Dakota Century Code section 60-02-25.1 provides that grain contained in a warehouse is subject to a first priority lien in favor of the outstanding receipt holders. On January 13, 2012 Anderson Seed Co., Inc. entered into a Purchase Order and Security Agreement to sell a significant amount of sunflower seeds. The Commission, acting as Trustee, investigated the possibility of initiating litigation against Anderson Seed Co., Inc., the owners of Anderson Seed Co. and the purchaser. The Commission, after considering the potential claims, potential defenses and evaluating the risks of litigation has agreed to resolve all of the potential claims for a payment of \$685,000. The resolution resolves all potential claims that may be asserted by the Commission against the parties listed in this paragraph and is not an admission of liability by any of the potential parties. The Commission has included within the settlement agreement a provision that allows the settlement to be set aside if it is determined that there has not been an accurate disclosure of net worth by Anderson Seed Co., Inc. and/or the owners of Anderson Seed Co., Inc.
18. Grain asset proceeds are insufficient to pay valid cash claimants. The \$280,000 bond proceeds are needed to redeem outstanding claims for grain purchased for cash by Anderson Seed Co., Inc. through its Durbin and Selz, North Dakota facilities.

19. When the bond proceeds are paid over to the Commission as Trustee, there will be funds available from the trust fund to pay each valid cash claimant approximately 43% of his valid claim.
20. The Commission recommends that the cash claimants be paid approximately 43% of the claimants' valid cash claims. The Commission recommends that payment for each cash claim be made jointly payable to the claimant and relevant valid lien holders at the time checks are issued. The final amounts to be paid will be determined once Court approval is received.
21. The valid cash claim amounts recommended by the Commission total \$2,233,147.18 as shown below and with additional detail in Exhibit B to the Affidavit of Timothy Erdmann, attached to this report:

22. Proceeds from the credit-sale contract indemnity fund will be needed to meet the insolvent licensee's obligations to holders of credit-sale contracts. Payments will be made to valid credit-sale claimants with the claimants receiving 80% of the claimants' valid claims under North Dakota Century Code section 60-10-06.
23. The Commission recommends that each credit-sale contract claimant be paid 80% of the claimant's valid credit sale claim as provided under North Dakota Century Code section 60-10-06. The Commission recommends that payment for each credit-sale claim be made jointly payable to the claimant and relevant valid lien holders at the time checks are issued.
24. The valid credit-sale claim amounts recommended for payment by the Commission total \$809,017.70 and by law each claimant is entitled to 80% of the respective valid credit-sale claim, as shown below and with additional detail in Exhibit C to the Affidavit of Timothy Erdmann, attached to this report:

Timothy Erdmann being duly sworn states as follows:

1. That he is a citizen of the United States of America, of legal age, residing at Denhoff, North Dakota.
2. That he is Licensing Division Grain Warehouse Inspector for the Public Service Commission (Commission).
3. That he evaluated the unpaid grain claims in the Anderson Seed Co, Inc. (Anderson Seed) warehouse insolvency to determine whether the claims were valid or invalid cash claims or valid or invalid credit-sale contract claims.

4. That he evaluated the claims filed with the Commission to determine the amount and validity of each claim based on the following factors:
 - a. Long-standing Public Service Commission precedent recognizes that a scale ticket issued by a North Dakota licensed warehouse is the best evidence of delivery to that licensed warehouse and constitutes the primary basis for determining the validity of a grain claim in an insolvency proceeding in North Dakota.
 - b. Long-standing Public Service Commission precedent also recognizes that purchase contracts with a North Dakota licensed warehouse delivery point are relevant in determining validity of a grain claim in an insolvency.
 - c. Long-standing Public Service Commission precedent also recognizes that the consideration of freight agreements and costs in determining claim validity. This consideration includes the following questions:
 - i. Did the claimant deliver the grain to the warehouse himself or pay the freight charges for that delivery?
 - ii. Did the insolvent warehouseman dispatch the freight and assess the freight charges to the claimant?
 - iii. Did the warehouseman direct the freight to bypass the licensed North Dakota purchase contract delivery point and proceed directly to another warehouse out of state (in this case Mentor, MN or Redfield, SD)?
 - iv. What freight rate was assessed when the warehouseman dispatched and directed the freight?

5. Affiant reviewed the filed claims and found they fell into one of six categories. Each category or type is described below, together with a description of how affiant analyzed each type of claim and his resulting conclusions as to validity. This review, analysis and conclusions were applied to each claim falling into each category.
6. **Claim type #1 - The most common.** The claimant delivered the grain to either Selz, ND or Durbin, ND, received a Selz, ND or Durbin, ND warehouse scale ticket. The purchase contract may or may not have designated the specific North Dakota location as the delivery point. The key factor in affiant's analysis is that North Dakota issued scale tickets are valid regardless of the delivery point designated in the purchase contract. A North Dakota issued scale ticket is the best evidence of delivery in North Dakota.
7. **Claim type #2-** This scenario is identical to claim type #1 except that Anderson Seeds dispatched the freight and the freight charges were assessed to the claimant. The key factor in affiant's analysis is that North Dakota issue scale tickets are valid regardless of the delivery point designated in the purchase contract. A North Dakota issued scale ticket is the best evidence of delivery in North Dakota.
8. **Claim type #3-** The claimant submitted a claim with a mix of scale tickets, some issued from Selz, ND or Durbin, ND and the remainder issued from Mentor, MN, or the claimant submitted a claim with all Mentor, MN issued scale tickets. The claimant's purchase contract designated Selz, ND or Durbin, ND as the delivery point. Based on affiant's review of the claim and available Anderson Seed

documents, affiant concluded that Anderson Seeds dispatched the freight and directed the unloading of that freight. Anderson Seeds controlled the freight destination resulting in these claims with a mix of scale tickets or with all Mentor, MN scale tickets. The freight charge assessed by Anderson Seeds to the claimant is the same, lower price whether the truck unloaded at the contract delivery point warehouse in North Dakota or at Mentor, MN. Anderson Seeds paid the additional freight from the North Dakota warehouse to Mentor, MN. In affiant's analysis, the North Dakota scale tickets definitely are valid. The Mentor, MN issued scale tickets should be determined valid because the purchase contract delivery point is a North Dakota warehouse. Affiant's recommendation is based on the fact that Anderson Seeds controlled the freight destination and assessed the same lower freight rate whether the grain was unloaded at a North Dakota warehouse or Mentor, MN. This constitutes evidence of delivery in North Dakota or the producer's intent to deliver in North Dakota.

9. **Claim type #4-** The claimant submitted a claim with a mix of scale tickets issued from Durbin, ND, Mentor, MN, and Redfield, SD. The purchase contract designated Redfield, SD as the delivery point. Based on affiant's review of the claim and available Anderson Seed documents, affiant concluded that Anderson Seeds dispatched and directed the freight. The Durbin, ND scale tickets were assessed a higher freight rate than the Redfield, SD or Mentor, MN scale tickets. The distance from the claimant's address to Durbin, ND is farther than the distance from claimant's address to Redfield, SD, thus that higher charge is reasonable. The Mentor, MN and Redfield, SD scale tickets were all assessed

the lower Redfield, SD freight rate. The Durbin, ND scale tickets are definitely valid. Affiant recommends that the Redfield, SD and Mentor, MN issued scale tickets be determined invalid based on the purchase contract delivery point of Redfield, SD and the lower freight rate assessed by Anderson Seeds on the Mentor, MN and Redfield, SD scale tickets. In this scenario, the North Dakota scale tickets are valid. The affiant recommends the claims based on Mentor, MN or Redfield, SD deliveries be determined invalid, as there is no evidence of delivery in North Dakota or producer intent to deliver in North Dakota.

10. **Claim type #5**- The claimant submitted a claim with a mix of scale tickets issued from Durbin, ND and Redfield, SD. The purchase contract designated Durbin, ND as the delivery point. The grain was delivered by the claimant at both locations. The Durbin ND scale tickets definitely are valid. Affiant recommends the Redfield, SD scale tickets be determined invalid, since the claimant made delivery himself over the state line to Redfield, SD.
11. **Claim type #6**- The claimant submitted scale tickets from Redfield, SD. The claimant's purchase contract designated Redfield, SD as the delivery point, and the freight not a factor. The claimant submitted scale tickets from Mentor, MN, the purchase contract designated Mentor, MN as the delivery point, and the freight is not a factor. Affiant recommends this type of claim be determined invalid because no North Dakota warehouse documents were filed and there is no evidence of North Dakota deliveries or an intent to make a North Dakota delivery. This scenario involves strictly out of state transactions.

12. Affiant used the following process and analysis to determine affiant's recommendations on valid claim amounts, resulting in some differences between the filed claim amount and the recommended amount for payment.
 - a. Numerous claimants did not allow for deduction of the mandatory sunflower promotion assessment of \$.04 (4 cents) per each net hundred weight. Affiant applied this assessment to all valid claims except the claim of Midwest Co-op/CHS, as the origination warehouse located in South Dakota was responsible for assessing this charge in this claim.
 - b. A few claimants received a payment from Anderson Seeds for on the farm storage of their sunflowers, if delivered after a certain date as designated in their purchase contract. Affiant considered these on the farm payments as preferential treatment by Anderson Seeds. Thus, affiant deducted the on the farm storage payment amounts from the net payable claims of those claimants who received this storage payment
 - c. Affiant discovered errors in claims and made corrections for them. Affiant applied appropriate quality discounts designated in the contracts, resulting in some claims being discounted and some claims being increased accordingly.
13. Anderson Seed Co, Inc. operated licensed warehouses at Selz, ND and Durbin, ND, Mentor, MN, and Redfield, SD. Affiant understands that the Selz, ND and Durbin, ND warehouses were basically receiving and storage warehouses with minimal processing capabilities, Mentor, MN was the major processing plant, and Redfield, SD had been recently constructed as a processing plant. Prior to the recent construction of the Redfield, SD plant, all of the sunflowers received at

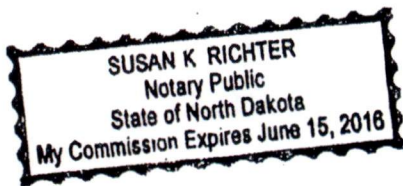
Selz, ND and Durbin, ND were transported at Anderson Seed's expense to the Mentor, MN processing plant.

1. This matter came before the Court on the motion of the North Dakota Public Service Commission (Commission) seeking approval of the Trustee's settlement regarding trust assets, approval of its Report and Recommendation as Trustee, deposit of bond proceeds, authorization for payment, and discharge as trustee. This matter was scheduled for hearing before this Court on **January 6, 2014 at 9:00 a.m. CDT** at the Cass County Courthouse in Fargo, North Dakota, with proper notice having been given as evidenced by the affidavit of mailing on file. The Commission appeared through _____, Special Assistant Attorney General, and Auto-Owners Insurance Company appeared through William Harrie. No other parties or claimants appeared.

2. The Court reviewed the report and other documents of record and finds grounds for approving the Trustee's settlement, the report and recommendation, requiring deposit of bond proceeds, authorizing payment, and subsequent discharge as trustee. There were no objections to the settlement, the report, the Trustee's recommendation, or the requests for deposit of bond proceeds, authorization of payment and subsequent discharge as trustee.

ORDER

IT IS THEREFORE ORDERED:

3. The Trustee's settlement regarding trust assets is approved.
4. The Report and Recommendation of Trustee, dated November 22, 2013, which recommends approval of the settlement, deposit of bond proceeds, distribution of bond proceeds to valid cash claimants, credit-sale contract indemnity fund payments to valid credit-sale claimants, and subsequent discharge of the Public Service Commission as Trustee, is approved.
5. The surety, Auto-Owners Insurance Company, PO Box 30660, Lansing, Michigan 48909-8160 deposit, within ten (10) days of the date of this order, the \$280,000 bond proceeds with the Trustee for deposit in the trust fund to pay valid cash claims.
6. The Commission, as Trustee, is authorized to make prorated payments from the trust fund to claimants with valid cash claims for grain purchased for cash by Anderson Seed Co., Inc., at its Durbin and Selz, North Dakota facilities as specified in the Report and Recommendation of Trustee. The Commission shall

make the payments for each cash claim jointly payable to the claimant and relevant valid lien holders at the time checks are issued.

7. The Commission, as Trustee, is authorized to make payment from the credit-sale contract indemnity fund to each holder of valid credit-sale contracts for grain sold to Anderson Seed Co., Inc., not to exceed the lesser of eighty percent of the amount owed to each claimant or two hundred eighty thousand dollars as specified in the Report and Recommendation of Trustee. The Commission shall make the payments for each credit-sale contract claim jointly payable to the claimant and relevant valid lien holders at the time checks are issued.
8. Upon distribution of the trust fund proceeds to the cash claimants and payment from the credit-sale contract indemnity to each holder of valid credit-sale contracts, as provided for in the Trustee's report and this Order, the Trustee is discharged.
