Enclosed please find check no. 13932 in the amount of \$19,711.68 drawn on the trustee's trust account in the referenced proceeding. This check represents approximately 43% payment of your client's cash claim.

The Commission, as trustee, had enough proceeds in its trust account to make approximately 43% payment to all valid cash claimants. The trust account was made up of the \$280,000 surety bond on file with the Commission at the time of insolvency, a \$685,000 settlement approved by the Court, proceeds from liquidating grain assets in the warehouse, and interest earned on the trust account.

Payments were approved by a North Dakota District Court Judge. The court's order in this case is final and our distribution of all trust fund assets closes this insolvency. Thank you for your patience and cooperation during this long proceeding.
