They can do the work, but they will need a month extension on the deadlines. No motion was needed at this time, per Mr. Lange.

The NDDOT Construction Engineering Services Agreement for County Federal Aid Project was discussed. NDDOT Contract No. 38120641 is for project CER-2303(064) which is located approximately 6 miles north of Kulm. The length of the project is

At 9:56 a.m., DES/911 Coordinator Kimberly Robbins gave an update on her department's activities. The FEMA Applicant Agent report was reviewed: Individual site folders are completed for DR1713 (Flood 2007) and disbursement of funds needs to be determined. DR1829 (Flood 2009) will close on 10/24/12 and DR1907 (Flood 2010) will close on 10/30/12. DR1981 (Flood 2011) received 46 project worksheets (PW's), over \$600,000 for small projects road-way repair and 9 PW's are still waiting for FEMA approval. There is no close date for 2011 yet.

Request for bids for the 2009 FEMA museum artifact conservation project will be mailed out. The bid deadline will be May 31st, 2012 and the bids will be discussed at the June 5th Commissioners meeting. Ms. Robbins is working with Matt Lange (KLJ) on the project. The project will need to be completed by October 1st, 2012.
