Dear Mr. Nitschke:

John Staurulakis, Inc. (JSI) is filing an original and seven (7) copies of the Table of Contents pages which is part of the new Intrastate Access Tariff that was filed with this Commission on May 15, 2012, and May 16, 2012 on behalf of the Issuing Carriers indicated in Attachment 1 to this transmittal letter, also referred to as the North Dakota Intrastate Access Coalition. Sections 1 through 16 were filed with the Commission on May 15, 2012, and due to technical difficulties, Section 17-Rate Sections were filed with the Commission on May 16, 2012. Due to an inadvertent oversight, the Table of Contents was not filed yesterday with Section 17 as intended.

Again, the purpose of this filing is to reflect recently enacted FCC rules pursuant to the FCC's Report and Order and Further Notice of Rulemaking, Docket No. WC Docket No. 10-90, *et al.*, FCC 11-161 (Released November 18, 2011).<sup>1</sup> The FCC's Rules in this Order became effective on December 29, 2011. This tariff filing establishes a new Intrastate Access Tariff for all of the Issuing Carriers, and supersedes and cancels any affiliation or concurrences that may currently exist between the Issuing Carriers and any other existing Intrastate Access Tariff, effective July 1, 2012.


