A prehearing conference for purposes of scheduling and narrowing the issues to be addressed at the June 21, 2012, hearing was held on June 7, 2012, at 10:00 a.m. and 2:30 p.m. in the hearing room of the Public Service Commission, North Dakota State Capitol, 12<sup>th</sup> Floor, Bismarck, North Dakota.

The hearing was attended by counsel for the Public Service Commission, Mark Gruman; Patrick Fahn, Director of Compliance; John Sisemore on behalf of potential interveners, AT&T of the Midwest; and David Hogue, attorney for the North Dakota Intrastate Access Coalition consisting of 23 local telephone companies, as identified in the above caption of the various cases consolidated herein.

Coalition indicated that its portion of the hearing would take approximately two hours, if not contested, and they would be presenting prefiled testimony from one or two witnesses.

IT IS ORDERED that the Coalition will file prefiled testimony and any supporting brief and position statement by 12:00 noon on June 19, 2012. Intervenors must formally intervene and file responsive prefiled testimony or briefing no later than 4:00 p.m. on June 20, 2012.

As previously noticed, the hearing in this matter is scheduled to commence at 8:30 a.m. on June 21, 2012, in the Public Service Commission Hearing Room, 12<sup>th</sup> Floor, State Capitol, Bismarck, North Dakota.
