NOTICE OF OPPORTUNITY FOR HEARING

June 14, 2012

On May 23, 2012, Missouri Valley Communications, Inc. (Case No. PU-12-206) and Wolverton Telephone Company (Case No. PU-12-217) filed with the North Dakota Public Service Commission (Commission) new switched access price schedule pages to reflect newly enacted Federal Communication Commission (FCC) rules regarding the treatment of VoIP-PSTN traffic (VoIP-PSTN price schedules), pursuant to the FCC's Report and Order and Further Notice of Rulemaking, WC Docket No. 10-90, *et al*, FCC 11-161 (Released November 18, 2011). The FCC's rules in this Order became effective on December 29, 2011.

On May 29, 2012, Dickey Rural Access, Inc. (Case No. PU-12-233) filed with the Commission VoIP-PSTN price schedules.

On June 5, 2012, Nemont Telephone Cooperative, Inc. (Case No. PU-12-208), Northwest Communications Cooperative, a Cooperative Association (Case No. PU-12-210), and Reservation Telephone Cooperative (Case No. PU-12-213) filed with the Commission VoIP-PSTN price schedules.

On June 14, 2012, the Commission suspended the VoIP-PSTN price schedules filed in each of the cases enumerated above.

The issue to be considered in this matter is whether the VoIP-PSTN price schedules filed by each of the companies in the cases enumerated above should be approved by the Commission. Those interested are invited to comment in writing. Persons desiring a hearing must file a written request identifying their interest in the proceeding and the reasons for requesting a hearing. Comments and requests for hearings must be received **by close of business on July 25, 2012.**


