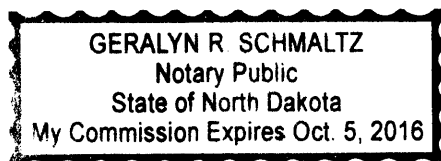

The FCC's Rules in this Order became effective on December 29, 2011. The price schedule filings are intended to supersede and cancel the existing intrastate access tariff of these companies. The FCC states that the new rates must be effective July 1, 2012.

On May 29, 2012, Dickey Rural Access, Inc. Case No. PU-12-233, filed with the Commission revised intrastate switched access price schedule pages to reflect the newly enacted FCC rules as stated above.

On May 30, 2012 the Commission suspended the intrastate switched access price schedules filed in each of the cases enumerated above.


Since the FCC's Report and Order and Further Notice of Rulemaking, Docket No. WC Docket No. 10-90, *et al*, FCC 11-161 states that the new rates must be effective July 1, 2012, the Commission finds an emergency exists for providing fewer than 20 days notice of the hearing. N.D. Admin Rule 69-02-04-01.

**A public hearing** on this matter will be held beginning **June 21, 2012 at 8:30 a.m.** in the Commission Hearing Room, State Capitol, 12<sup>th</sup> Floor, Bismarck, North Dakota 58505. The issue to be considered is whether the intrastate switched access price schedules filed by each of the companies in the cases enumerated above should be approved by the North Dakota Public Service Commission.




