John Staurulakis, Inc. (JSI) is filing an original and seven (7) copies of the enclosed revised Section 17 Rate Sheets that are part of the new North Dakota Intrastate Access Tariff No. 1 (NDIAT) that was filed on behalf of the Issuing Carriers indicated in Attachment 1 to this transmittal letter, also referred to as the North Dakota Intrastate Access Coalition. Again, the purpose of this filing is to reflect recently enacted FCC rules pursuant to the FCC's Report and Order and Further Notice of Rulemaking, Docket No. WC Docket No. 10-90, *et al.*, FCC 11-161 (Released November 18, 2011).¹

As you know, this tariff was originally filed with the North Dakota Public Service Commission (NDPSC or Commission) on May 15, 16, and 17, 2012, with revisions filed on June 5, 2012. However, we have recently discovered some additional errors with the Section 17 Rate Sheets that we would like to correct at this time. The errors range from typographical, errors to modified rates for some companies.

The specific tariff pages being filed are identified on the Check Sheets contained in the Table of Contents of this tariff. This tariff filing is made under authority of Chapter 49-21-01 and Chapter 49-21-04. The Issuing Carriers propose an effective date of this new Intrastate Access Tariff of July 1, 2012.

Attachment 2 to this transmittal letter provides a detailed account of exactly what revisions have been made to the Section 17 Rate Sheets being submitted today, when compared to the version of these rate sheets previously filed with this Commission, as well as identifies specifically which pages have been revised. Although only one or two rate sheets may have actually been revised for each company noted above, for your convenience JSI is filing a complete set of the Section 17 Rate Sheets for each company. Using this approach, the new Section 17 Rate Sheets filed today for these companies can simply replace the Section 17 Rates Sheets that you already have for these companies.

Additionally, and as you know, in a Letter Order issued by the NDPSC on May 3, 2012, the Commission delineated a list of specific supporting information that must be provided with this tariff filing. A portion of this information has been determined to be confidential, and was submitted to this Commission in a separate filing of an Application for Trade Secret Protection. However, none of the rate sheet revisions being filed today will impact the confidential worksheets that were previously filed with this Commission.

This tariff filing is being filed electronically, and it consists of four (4) electronic files. The first, second and third files contain this transmittal letter and the two (2) Attachments to the transmittal letter as described above. The fourth file contains the Section 17 Rate Sheets revisions for the companies noted above. Please respond via email with a notification indicating that this filing has been received by the Commission.

As a final point, JSI will be mailing the hard copies of the tariff filing as noted above, to the Commission today, via overnight mail, for delivery to the Commission tomorrow, June 15, 2012. 17.3.5 Specialized Service or Arrangements

17.4 Rates Schedule for Transition from Non-LTR Rate Design to LTR Rate Design

17.4.1 General

The Company will be transitioning terminating access rates according to the Federal Communication Commission's USF/ICC Reform Order issued on November 18, 2011. Terminating switched access will transition from Non-LTR Rate Design to LTR Rate Design for a transition period beginning July 1, 2012 through June 30, 2013. Terminating End Office access elements will transition from their current levels to zero between July 1, 2012 through June 30, 2020. Accordingly, West River will file revised rates annually to comply with the USF/ICC Reform Order.

*LTR denotes Local Transport Restructuring
