**ORDER  
June 27, 2012**

The evidence of record has been considered and appraised.

The Commission has jurisdiction over the parties and subject matter and the rate of return companies who have filed intrastate access tariffs in this consolidated case. 2. The Commission does not possess subject matter jurisdiction over SRT Communications, Inc. as a price cap carrier.


The Commission takes Administrative Notice of all switched access price schedules filed by the Companies herein submitted to the Commission due to newly enacted FCC rules pursuant to the FCC's Report and Order and Further Notice of Rulemaking, Docket No. WC Docket No. 10-90, *et al*, FCC 11-161, released November 18, 2011; and the FCC's Order, WC Docket No. 10-90, *et al*, FCC DA 12-870, released June 5, 2012.

The switched access price schedules are just and reasonable.

The Commission Orders:

1. The Hearing Officer's June 26, 2012 Recommended Findings of Fact, Conclusions of Law and Recommended Order, a copy of which is attached to this Order and made a part of this Order, is ADOPTED as the Public Service Commission's Findings of Fact, Conclusions of Law and Order.
2. The switched access price schedules of the rate of return companies are APPROVED.

## Preliminary Statement

On November 18, 2011, the Federal Communications Commission ("FCC") issued its Universal Service/Intercarrier Compensation Reform Order - FCC 11-161 ("Transitional Order"). See *Connect America Fund, et al., WC Docket NO. 10-90 et al., Report and Order and Further Notice of Proposed Rulemaking, FCcd 11-161 (rel. Nov. 18, 2011)*. The Transitional Order requires a series of transitional intrastate access charge reductions for both price cap and rate of return carriers with the first reduction to be effective July 1, 2012. Twenty one (21) rate of return carriers and one price cap carrier (SRT Communications, Inc.) filed intrastate North Dakota tariffs with the North Dakota Public Service Commission.

Following the November 2011 Transformation Order, the FCC issued an order on June 5, 2012 in the same docket that clarified rural LECs' duty to reduce intrastate access charges. The June 5, 2012 order granted rural LECs considerable flexibility in meeting the step one intrastate access revenue reductions.

The following companies filed tariffs for approval reflecting that transitional intrastate access charge reduction:

Several companies subsequently filed technical corrections to the filed Intrastate Access Tariffs prior to evidentiary hearing.

The Commission scheduled an evidentiary hearing regarding this matter for June 21, 2012 at 8:30 am CST at the Commission hearing room by Notice of Consolidated Hearing dated May 30, 2012. The filing companies appeared at the hearing with counsel, David Hogue. The Commission was represented by Mark Gruman and Patrick Fahn. The issue to be considered was whether the intrastate switched access price schedules filed by each of the companies in the cases enumerated should be approved by the North Dakota Public Service Commission. A prehearing conference as held June 7, 2012. The filing companies presented pre-filed testimony from Douglas Meredith of JSI. Mr. Meredith's pre-filed testimony was offered and received into evidence as Exhibit 1, along with two attachments to his testimony, Exhibits 2 and 3. Mr. Meredith appeared in person and provided live testimony. No third parties intervened in this matter or appeared at the evidentiary hearing.

#### **Findings of Fact**

1. The tariffs filed by the twenty one (21) rate of return companies referenced above and SRT Communications, Inc., a price cap company, comply with the FCC requirements found in CFR §51.907(b) (for Price Cap Carriers) and CFR §51.909(b) (for Rate-of-Return Carriers), and follow all necessary guidelines for adjustment required by FCC order.

**Conclusions of Law**


1. The Commission has jurisdiction over the parties and subject matter and the rate of return companies who have filed intrastate access tariffs in this consolidated case.
2. The Commission does not possess subject matter jurisdiction over SRT Communications, Inc. as a price cap carrier.
3. The Commission takes Administrative Notice of all revised tariffs filed by the Companies herein pursuant to new FCC rules cited above.
4. The Tariffs filed by all companies, and subsequent technical corrections referenced above are just and reasonable and should be approved to become effective July 1, 2012.

**Recommendation**

The ALJ hereby recommends that the Commission Order:

The tariffs filed by the rate of return companies and SRT Communications, Inc. are in accordance with federal law and guidelines and should be accepted and approved to become effective July 1, 2012.
