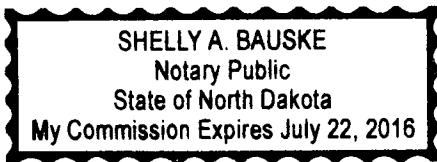



**ORDER REVOKING AUCTION CLERK LICENSE**

**May 30, 2012**

Travis James Schweitzer, Bismarck, North Dakota holds auction clerk license number 618 issued by the Public Service Commission under the provisions of NDCC Chapter 51-05.1.

On March 16, 2012, the Commission was notified that the bond issued to Travis James Schweitzer would be cancelled effective May 20, 2012. NDCC Chapter 51-05.1 requires that auction clerks maintain adequate bond coverage and provides that the Commission, without hearing, shall revoke the license effective the date the bond is cancelled unless a new bond is filed or notice to reinstate the cancelled bond is received. No bond or reinstatement was filed and auction clerk license number 618 issued to Travis James Schweitzer is revoked.

**Order**

The Commission orders that:

1. Auction clerk license number 618 issued to Travis James Schweitzer is revoked as of May 20, 2012,
2. Travis James Schweitzer can no longer clerk at public auction under auction clerk license number 618, and
3. Auction clerk license number 618 shall be surrendered to the Commission immediately.
