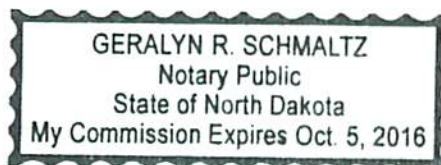

NOTICE OF HEARING  
April 24, 2013

On March 22, 2013, Public Service Commission Advocacy Staff filed a formal complaint alleging violation of the North Dakota One-Call law, N.D.C.C. Chapter 49-23, and requesting the Commission find the Kindred Plumbing and Heating, Inc. responsible for violating the One Call law and impose a penalty of \$1,500.00.

On March 27, 2013, the Public Service Commission found the Complaint states a prima facie case and served the complaint on the Respondent on March 28, 2013.


A public hearing on this matter will be held commencing on **June 14, 2013 at 10:00 a.m. CDT** in the Commission Hearing Room, State Capitol, 12th Floor, Bismarck, North Dakota 58505. The issues to be considered are:

1. Has respondent, Kindred Plumbing and Heating, Inc., violated N.D.C.C. Chapter 49-23, the North Dakota One-Call law?
2. If a violation is found, should the Commission impose a civil penalty in the amount of \$1,500.00?
