



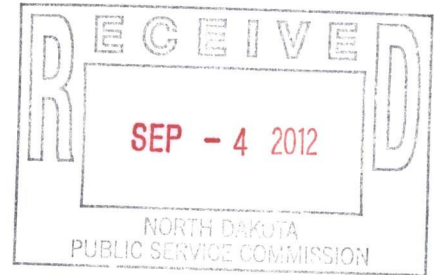


**MOTION FOR THE ADMISSION PRO HAC VICE


