
ORDER GRANTING ADMISSION PRO HAC VICE

On September 4, 2012, Zack Pelham of the firm of Pearce & Durick, filed a Motion for Admission Pro Hac Vice, and Affidavit of Russell M. Blau, with the North Dakota Public Service Commission. Mr. Blau seeks admission to practice pro hac vice in North Dakota, representing YMax before the Commission in AT&T v. YMax, PU-12-433. On July 5, 2012, Administrative Law Judge Patrick J. Ward was designated to preside as procedural hearing officer in AT&T v. YMax, PU-12-433.
