Dear Mr. Nitschke:

Please accept this filing on behalf of Polar Communications Mutual Aid and its subsidiaries ("Polar"), reporting, pursuant to FCC Rule § 54.304(d) (1), projected eligibility for CAF ICC funding during the upcoming funding period pursuant to § 51.917 of the FCC rules.

Section § 54.304 details the "Administration of Connect America Fund Intercarrier Compensation Replacement" for the funding period beginning July 1 through June 30 of the following year. Accordingly, Polar through the National Exchange Carrier Association, has filed the requisite data with the Universal Service Administration Company ("USAC") and the FCC in preparation for the upcoming 2012-2013 interstate access period. Section § 54.304(d)(1) also requires that a copy of this confidential data be filed with the "relevant state commission no later than June 30, 2012."

To timely submit this filing with you under the FCC Rule, I am providing here the Redacted / Public version of Polar's projected eligibility for CAF ICC funding for the upcoming fiscal period as well as certifications as to the accuracy of this filing. Polar is in the process of preparing an application for trade secret status and will file it along with non-redacted versions of this filing as soon as it is completed.
