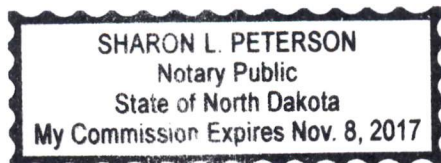

HEARING
March 27, 2013**

On September 17, 2012 ONEOK Rockies Midstream, L.L.C. (ONEOK) submitted an application for a certificate of site compatibility for the construction of a 100 million standard cubic feet per day gas processing plant, known as the Garden Creek II Plant, to be located approximately 4.3 miles northeast of Watford City in McKenzie County, North Dakota.

On December 21, 2012, the Commission adopted its order and issued Certificate of Site Compatibility No. 31 to ONEOK for construction of the Garden Creek II Plant on an 80-acre plot directly north of, and adjacent to, the 80-acre plot on which ONEOK's Garden Creek I Plant is constructed.

On March 6, 2013, ONEOK filed an application with the Commission to amend Certificate of Site Compatibility No. 31 for the construction of a third gas processing plant, known as the Garden Creek III Plant, within the boundaries of the 80-acre plot on which ONEOK's Garden Creek II Plant will be constructed, as shown on the attached map.

The issues to be considered in ONEOK's application to amend Certificate of Site Compatibility No. 31 are:

1. Will the location, construction, and operation of the proposed facility produce minimal

adverse effects on the environment and upon the welfare of the citizens of North Dakota?

2. Is the proposed facility compatible with the environmental preservation and the efficient use of resources?

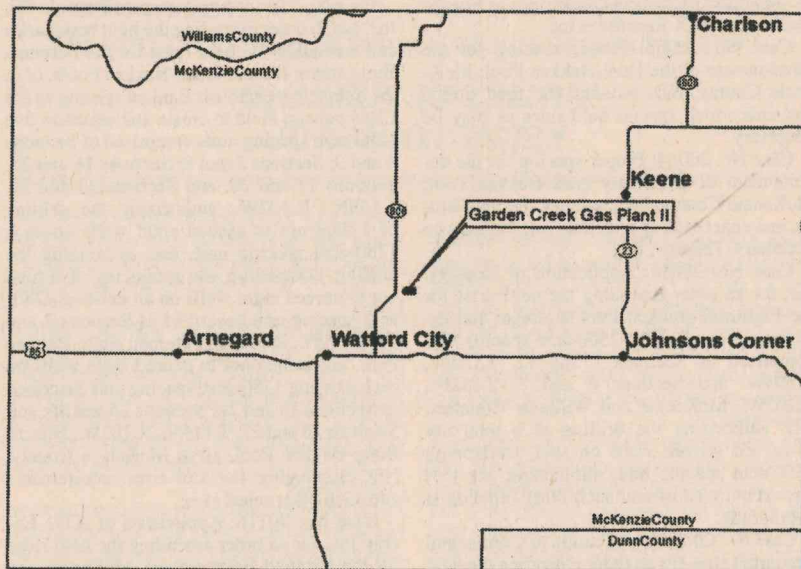
3. Will the proposed facility location minimize adverse human and environmental impact while ensuring continuing system reliability and integrity and ensuring that energy needs are met and fulfilled in an orderly and timely fashion?

Those interested are invited to comment on the application in writing. Persons desiring a hearing must file a written request identifying their interest in the proceeding and the reasons for requesting a hearing. Comments and requests for hearing must be received by close of business on April 30, 2013. If deemed appropriate, the Commission can determine the matter without a formal hearing.
