
I am pleased to appoint you as a special assistant attorney general for the State of North Dakota. The two appointments are for you to:

I take this opportunity to remind you that you may not undertake work on behalf of a state agency or entity beyond the scope of your appointment. I also encourage you to work with ND PSC to ensure timely reporting of your fees and expenses as required by N.D.C.C. § 54-12-13. The agency is required to report each month, even if no such expenses are incurred. If applicable to your appointment, I also draw your attention to the requirement to provide quarterly litigation status reports and to report any significant developments.
