The contents of the foregoing affidavit are true and correct as I verily believe.

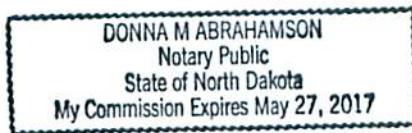
