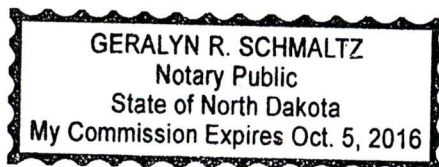

**Preliminary Statement**

On August 31, 2012, Dakota Central Telecommunications Cooperative (Case No. PU-12-708), Dakota Central Telecom I, Inc. (Case No. PU-12-709), Dickey Rural Telephone Cooperative (Case No. PU-12-710), Dickey Rural Access, Inc. (Case No. PU-12-711), Griggs County Telephone Co. (Case No. PU-12-712), Inter-Community Telephone Company, L.L.C. (Case No. PU-12-713), Moore and Liberty Telephone Company (Case No. PU-12-714), Nemont Telephone Cooperative, Inc. (Case No. PU-12-715), North Dakota Telephone Company (Case No. PU-12-716), Polar Communications Mutual Aid Corporation (Case No. PU-12-717), Red River Rural Telephone Association (Case No. PU-12-718), Reservation Telephone Cooperative (Case No. PU-12-719), United Telephone Mutual Aid Corporation (Case No. PU-12-720), West River Telecommunications Cooperative (Case No. PU-12-721) and Wolverton Telephone Company (Case No. PU-12-722) filed with the North Dakota Public Service Commission (Commission) switched access price schedule pages to address a variety of formatting, textual, and rate revisions.

On September 12, 2012, a Notice of Opportunity for Hearing concerning the cases enumerated above was issued by the Commission. The Notice identified the issue to be considered in the cases is whether price schedules filed by each of the companies should be approved by the Commission. The Notice provided until close of

business on October 26, 2012 for comments or requests for hearing. No comments or requests for hearing were received by the Commission.

The Commission has jurisdiction over the parties and subject matter and the rate of return companies who have filed intrastate access tariffs in this consolidated case.

The Commission takes Administrative Notice of all the switched access price schedules filed by the Companies herein submitted to the Commission.

The switched access price schedules are just and reasonable.

Having allowed all interested persons an opportunity to be heard, and having heard, reviewed, and considered this matter, the Commission makes the following:

The Commission orders that the switched access price schedules are APPROVED.
