COMPLAINT

The North Dakota Public Service Commission Staff (Staff), for its complaint against Pacific Telecom Communications Group, Inc., alleges and shows the following:

I

Pacific Telecom Communications Group, Inc. (Pacific) is a California corporation with principle offices at 12228 Venice Boulevard, Suite 559, Los Angeles, CA 90066.

II

On December 15, 2009 Pacific completed a registration, using the Commission's electronic web-based form, to provide local services in Belfield, Bismarck, Casselton, Comstock, Dickinson, Emerado, Fairview, Fargo-West Fargo, Gardner, Grafton, Grand Forks, Hatton, Hillsboro, Jamestown, Kindred, Larimore, Leonard, Mayville, Minto, Mandan, Manvel, Northwood, Reynolds, Sabin MN, Sidney MT, Thompson, Valley City and Wahpeton exchanges of North Dakota. The registration must include identification of the applicant's authority to do business in North Dakota.

III

According to National Number Pool Administration website reports at www.nationalpooling.com/ , Pacific has acquired blocks telephone numbers in the Bismarck, Center, Dickinson, Emmet, Martin, Minot, and Spencer rate centers of North Dakota.

IV

On February 17, 2010 Steve Hamilton, CEO for Pacific, filed with the North Dakota Public Service Commission (Commission) a negotiated interconnection agreement between Pacific and Qwest Corporation (Qwest). The terms of the agreement allowed Pacific access to unbundled network elements, ancillary services, and telecommunications services available for resale where Qwest is providing local exchange service within North Dakota.

V

Pacific was granted a certificate of authority in Oregon on February 16, 2010. After failing to respond to two requests for their annual report by the Oregon Commission, the Oregon Commission cancelled Pacific's certificate of authority on August 3, 2012. (Please see attached Order).

VI

N.D.C.C. § 49-03.1-09(2)(g), if Pacific has its authority to provide service revoked, it has fifteen days to update this Commission of the date and jurisdiction of revocation. As of the date of this Complaint, no such information has been provided to the Commission by Pacific.

VII

N.D.C.C. § 49-03.1-09(4) allows the Commission to revoke a company's registration, after notice and hearing under chapter 28-32, for violation of any law, rule, or order the Commission.

VIII

N.D. Admin Code § 69-02-02-03(1) requires that an answer to this complaint must be served upon the Commission within twenty days after service of this complaint and notice of hearing or the Commission may deem the complaint to be admitted. Answers must be served in the manner allowed for service under the North Dakota Rules of Civil Procedure.


Prayer for Relief

Wherefore, Public Service Commission Staff seeks the following relief:

1. That the Commission find Pacific in violation of North Dakota Century Code Chapter 49-03.1 for failing to comply with the registration requirements outlined in North Dakota Century Code § 49-03.1-09(2)(g).

2. That the Commission revoke Pacific's registration.
3. Such other relief that the Commission finds just and proper.
