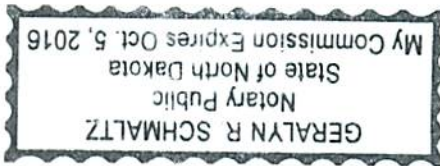

NOTICE OF HEARING

November 9, 2012

On October 1, 2012 the North Dakota Public Service Commission Advocacy Staff filed a Complaint alleging that Pacific Telecom Communications Group, Inc. is in violation of North Dakota Century Code, Chapter 49-03.1 for failing to comply with statutory registration requirements.

On October 10, 2012, the North Dakota Public Service Commission found the Complaint states a *prima facie* case. The Complaint was mailed to the Respondent on October 1, 2012.

A public hearing on this matter will be held **January 17, 2012 beginning at 9:00 a.m.** in the Commission hearing room, State Capitol, 12th Floor, Bismarck, North Dakota 58505. The issues to be considered in this matter are:

1. Did Respondent violate any law, rule or order of the Commission?
2. Should Respondent's registration be revoked?
