Page 17-1	Section 17.1.1 Originating Carrier Common Line should be \$0.0229 instead of \$0.029 for both IntraLATA and InterLATA.
Page 17-5	Section 17.3.6 Transitional Rate LTR-IntraLATA has been updated to indicate "terminating" traffic.
<b>Daktel Communications, Inc.</b>	
Page 17-22-23	Section 17.3.2 and 17.3.3 Titles no longer specify either IntraLATA or InterLATA. Section 17.3.2 (E)(F)(G) rate was changed from \$0.00 to N/A since these services are not offered by DakTel.
Page 17-24	Daktel has made an adjustment to allow the IntraLATA and InterLATA rates to be the same. The Transitional rate was adjusted to match the 50% decline in access revenue when combining the usage for both North Dakota LATAs. Section 17.3.6 Transitional rate should be .027083 instead of \$.027585 for IntraLATA and \$0.025795 for InterLATA. A single transitional rate now applies state wide. The title has also been updated to include the word "terminating".
Pages 17- 25-27	Sections 17.3.7 thru 17.3.11 have been deleted since IntraLATA and InterLATA rates are the same and combined as a single rate for the state. Titles have been changed to delete the word "IntraLATA or InterLATA"
Page 17-36-37	The IntraLATA and InterLATA were combined into a single table. One table on PG 36 was deleted and the title of the table on Pg 36 was changed to deleted reference to IntraLATA. In addition the rate elements for services not offered were changed from \$0.000 to N/A
<b>Midstate Communications</b>	
Page 17-39	Section 17.1.1 Carrier Common Line Termination IntraLATA rate Group 1 was adjusted to \$0.007533 from \$0.018772 and Section 17.1.2 Carrier Common Line Termination IntraLATA rate Group 2 was adjusted to \$0.025433 from the previous filing of \$0.036672. The change in CCL corrects the Access Charge Adjustment change.
