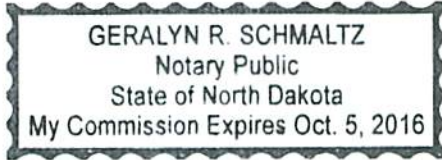

NOTICE OF OPPORTUNITY FOR HEARING

October 10, 2012

On October 1, 2012 Otter Tail Power Company, an electric public utility, filed an application under Chapter 49-03, N.D.C.C. to extend service to Rural Tower Network at a location in Cass County, North Dakota.

Submitted with the application was a statement by Rural Tower Network that the customer desires electric service to be provided by the applicant. Service is to be provided at a point located in:
