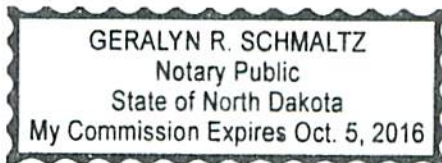

COMPLAINT

The North Dakota Public Service Commission Staff (Staff), for its complaint against S. J. Louis Construction, Inc., alleges and shows the following:

I

S. J. Louis Construction, Inc. (S. J. Louis) is a Minnesota corporation, registered with the North Dakota Secretary of State, with principal offices at 1351 W Broadway St., PO Box 459, Rockville, MN 56369-0459.

II

Reservation Telephone Cooperative (RTC) is a North Dakota cooperative association with principle offices at 24 N Main St, Parshall, North Dakota 58770-0068.

III

On November 29, 2012, the Commission received a Third Party Damage Complaint form from Alicia M. Brenna, attorney for RTC. The complaint alleged a

violation by S. J. Louis of North Dakota Century Code Chapter 49-23 and is attached as Exhibit 1.

IV

As part of the Third Party Damage Complaint, RTC included documentation proving that S. J. Louis obtained North Dakota One Call (One Call) ticket number 12141843 on September 4, 2012 at 8:04 AM for work to begin on September 6, 2012 at 8:00 AM.

V

As alleged by RTC, on September 6, 2012, S. J. Louis was excavating as defined under North Dakota Century Code section 49-23-01(7) to install city sewer near Highway 85 and 11th Avenue in Watford City, ND. As a result of this excavation, damage was caused to underground cable TV facilities of RTC resulting in the need for RTC to repair these damages at a cost of \$10,273.05.

VI

North Dakota Century Code § 49-23-05 (5) states:

To avoid damage to and minimize interference with underground facilities in and near the construction area, an excavator shall: Conduct the excavation in a careful and prudent manner.

VII

S. J. Louis violated North Dakota Century Code Section 49-23-05 (5) by failing to conduct the excavation in a careful and prudent manner.

VIII

The North Dakota Public Service Commission Damage Prevention Plan states:

D PROPOSED CIVIL PENALTIES:

1. The following criteria must be used by Commission staff to determine if a civil penalty should be proposed when filing a formal complaint:
 - a. The nature, circumstances and severity of the complaint;
 - b. The degree of suspected fault on the part of the respondent;
 - c. The respondent's history of prior violations or complaints;
 - d. The respondent's ability to pay;
 - e. Any good faith effort by the respondent in attempting to achieve compliance; and
 - f. The effect the penalty may have on the respondent's ability to continue in business.

IX

North Dakota Century Code § 49-07-01.1 states:

Any person who violates any statute, commission order, or commission rule which applies to matters within the authority of the commission under chapters 8-08, 8-09, 8-10, 24-09, 32-25, and 51-05.1, titles 60 and 64, and title 49 except for chapter 49-22, shall, in addition to any other penalty provided, be subject to a civil penalty of not to exceed five thousand dollars. The civil penalty may be compromised by the commission. The amount of the penalty when finally determined or agreed upon in compromise, if not paid, may be recovered in a civil action in the courts of this state.

X

By its December 10, 2012 letter, Staff informed S. J. Louis of RTC's third party damage complaint filing, and asked for a response to the complaint of Otter Tail by December 24, 2012. A response, dated December 19, 2012, was received on December 20, 2012 by Staff, wherein S. J. Louis asserted it conducted its excavation in a careful and prudent manner.

XI

Commission records indicated that two other complaints have been filed regarding S. J. Louis. In Case No. PU-12-93, originated by Aux Sable Midstream LLC, S. J. Louis failed to provide an excavation or location notice as required by state law at least forty-eight hours before excavation. In Case No. PU-12-800, originated by RTC, S. J. Louis is alleged to have failed to excavate in a careful and prudent manner and damaged fiber optic and copper cable lines. S. J. Louis has indicated its desire to sign a consent order in Case No. PU-12-800.

XII

North Dakota Century Code section 28-32-21(e) requires that an answer to this complaint must be served upon the Commission within twenty days after service of the complaint, or the Commission may deem the complaint to be admitted. If S. J. Louis fails to answer within twenty days after service of the complaint, the Commission may deem the Complaint admitted. Answers must be served in the manner allowed for service under the North Dakota Rules of Civil Procedure.

Prayer for Relief

Wherefore, Public Service Commission Staff seeks the following relief:

1. That the Commission find S. J. Louis in violation of North Dakota Century Code Chapter 49-23 for failing to comply with the One Call procedures outlined in North Dakota Century Code § 49-23-04.
2. That the Commission impose a civil penalty in the amount of \$1,000.00.
3. Such other relief that the Commission finds just and proper.

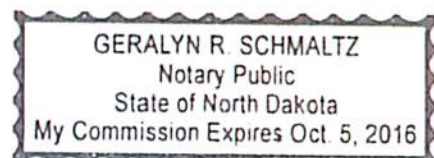
