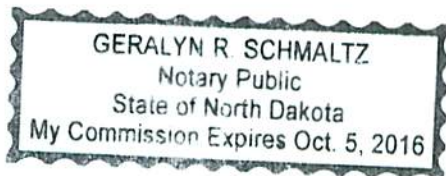

ORDER OF DISMISSAL

April 10, 2013

On December 10, 2012, North Dakota Manufactured Housing Association (NDMHA) filed a Complaint against Montana-Dakota Utilities Co. (MDU) asking the Commission to require MDU to notify lessors and landlords with advance notice of any intent to disconnect service to a customer lessee if MDU has a waiver from the customer lessee.

On December 12, 2012, the North Dakota Public Service Commission found the Complaint states a *prima facie* case and issued a Notice of Hearing, scheduling a hearing for February 19, 2013. Both the Complaint and the Notice of Hearing were served on MDU December 13, 2013.

On December 27, 2012 MDU filed an Answer to Complaint.

On January 8, 2013 MDU filed a Motion to Dismiss.

On January 29, 2013 NDMHA filed a Stipulation for Continuance.


On February 4, 2013 the Administrative Law Judge issued a Notice of Indefinite Continuance and cancelled the February 19, 2013 hearing.


On March 27, 2013 NDMAH and MDU filed a Stipulation for Dismissal.
