On March 21, 2013, Zeviel Simpser (North Dakota Bar # 06794), of the firm of Briggs and Morgan, P.A., 2200 IDS Center, 80 South 8th Street, Minneapolis, Minnesota, filed a Motion for the Admission Pro Hac Vice of Michael J. Bradley, of the firm of Moss & Barnett, 4800 Wells Fargo Center, 90 South Seventh Street, Minneapolis, Minnesota, and Affidavit of Michael J. Bradley, with the North Dakota Public Service Commission. Mr. Bradley seeks admission to practice pro hac vice in North Dakota, representing Northern States Power Company before the Public Service Commission in the case of Northern States Power Company, PU-12-813. On January 30, 2013, Administrative Law Judge Bonny M. Fetch was designated to preside as procedural hearing officer in this matter. The Public Service Commission has requested the administrative law judge rule on the motion.



Michael J. Bradley shall further comply with the requirements of North Dakota Supreme Court Admission to Practice Rule 3 during the course of his representation of Northern States Power Company in case number PU-12-813.
