On June 7, 2013, Zeviel Simpser (North Dakota Bar # 06794), of the firm of Briggs and Morgan, P.A., 2200 IDS Center, 80 South 8th Street, Minneapolis, Minnesota, filed a Motion for the Admission Pro Hac Vice of Alison C. Archer, Assistant General Counsel at Xcel Energy Services Inc., 414 Nicollet Mall, Minneapolis, Minnesota, along with an Affidavit of Alison C. Archer, with the North Dakota Public Service Commission. Ms. Archer seeks admission to practice pro hac vice in North Dakota, representing Northern States Power Company before the Public Service Commission in the case of Northern States Power Company, PU-12-813. On January 30, 2013, Administrative Law Judge Bonny M. Fetch was designated to preside as procedural hearing officer in this matter. 
