

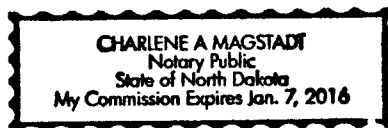

**ORDER REVOKING AUCTIONEER LICENSE**

**December 21, 2012**

Mike Murphy, Cave Junction, Oregon, holds auctioneer license number 906 issued by the Public Service Commission under the provisions of NDCC Chapter 51-05.1.

On October 19, 2012, the Commission was notified that the bond issued to Mike Murphy would be cancelled effective December 19, 2012. NDCC Chapter 51-05.1 requires that auctioneers maintain adequate bond coverage and provides that the Commission, without hearing, shall revoke the license effective the date the bond is cancelled unless a new bond is filed or notice to reinstate the cancelled bond is received. No bond or reinstatement was filed and auctioneer license number 906 issued to Mike Murphy is revoked.

**Order**

The Commission orders that:

1. Auctioneer license number 906 issued to Mike Murphy is revoked as of December 19, 2012,
2. Mike Murphy can no longer cry at public auction under auctioneer license number 906, and
3. Auctioneer license number 906 shall be surrendered to the Commission immediately.
