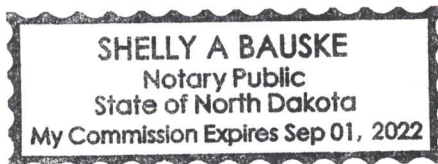

ORDER ON PROTECTION OF INFORMATION

MARCH 14, 2018

On December 4, 2013, Total Call Mobile, Inc. (TCM or the Company) filed an application for protection of information pursuant to North Dakota Administrative Code Section 69-02-09-01 requesting a protective order limiting disclosure of "Trade Secret" information.

TCM seeks protection of information as it pertains to TCM's "Commercial Information and Investigatory Work Product". The information relates to the Company's insight into its business structure and strategies and public exposure may infringe upon TCM's proprietary rights, cause undue harm to TCM, and allow competitors an unfair competitive advantage. TCM asserts that the information has not been previously exposed.

North Dakota Administrative Code Section 69-02-09-03 requires that the Commission staff examine the information and application and make a recommendation to the Commission. Commission Staff has reviewed the request and recommends that the application for protection of information be granted.

Having reviewed the Company's application and Commission Staff's recommendation, the Commission has determined that the information satisfies the requirements of North Dakota Century Code for protection of information.

ORDER

The Commission Orders the December 4, 2013 application of Total Call Mobile, Inc. for Protection of Information is GRANTED.
