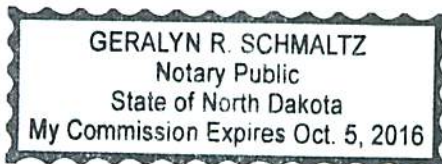

ORDER REISSUING CERTIFICATE AND PERMIT

May 8, 2013

On October 18, 1995, in Case No. PU-440-95-145, the Commission issued Certificate of Corridor Compatibility No. 68 and Route Permit No. 83 to Portal Pipeline Company for the construction of approximately eight miles of pipeline beginning near the Lignite Station in Burke County, North Dakota, and traversing in a northerly direction to the Canadian border, approximately four miles west of Portal, North Dakota.

On December 16, 1998, in Case No. PU-440-98-573, the Commission approved the transfer of said certificate and permit to Enbridge Pipelines (North Dakota) Inc. and issued First Reissued Certificate of Corridor Compatibility No.68 and First Reissued Route Permit No. 83.

On May 9, 2001, in Case No. PU-1984-01-122, the Commission approved the transfer of said certificate and permit to Enbridge Pipelines (North Dakota) LLC and issued Second Reissued Certificate of Corridor Compatibility No.68 and Second Reissued Route Permit No. 83.

On January 3, 2013, Enbridge Pipelines (North Dakota) LLC and Enbridge Pipelines (Bakken) L.P. (Enbridge Bakken) submitted a joint application for the transfer of Certificate of Corridor Compatibility Number 68 and Route Permit Number 83 to Enbridge Bakken, Case No. PU-12-823.

On January 30, 2013, the Commission issued a Notice of Opportunity for Hearing that provided until March 14, 2013 for receiving written comments or requests for hearing. No comments or requests for hearing were received. The notice stated the issues to be considered are whether Enbridge Bakken agrees and is able to comply with the terms and conditions of Corridor Compatibility Number 68 and Route Permit Number 83 to Enbridge ND, and whether the requested transfer is compatible with the public interest.

The April 29, 2013 affidavit of Chris Kaitson, Vice President & Assistant Secretary, states that Enbridge Bakken agrees to assume the rights and obligations of Certificate of Corridor Compatibility Number 68 and Route Permit Number 83, including the conditions and limitations set forth in the Commission's Findings of Fact, Conclusions of Law, and Order, dated October 18, 1995, issuing said Certificate and Route Permit, Case No. PU-440-95-145.




The requested transfer is compatible with the public interest.
