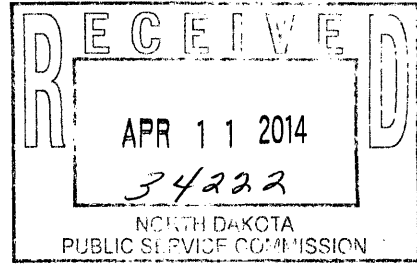

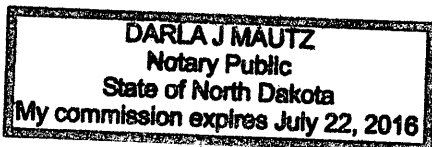

Notice is hereby given that on Tuesday, June 10, 2014 the annual school election will be held. The polling site


will be at the Underwood Public School. Polls will open at 11:00 a.m. and close at 7:00 p.m.

The school board members whose three year term expires in June: Brad Landenberger, City of Underwood - Mike Heger.

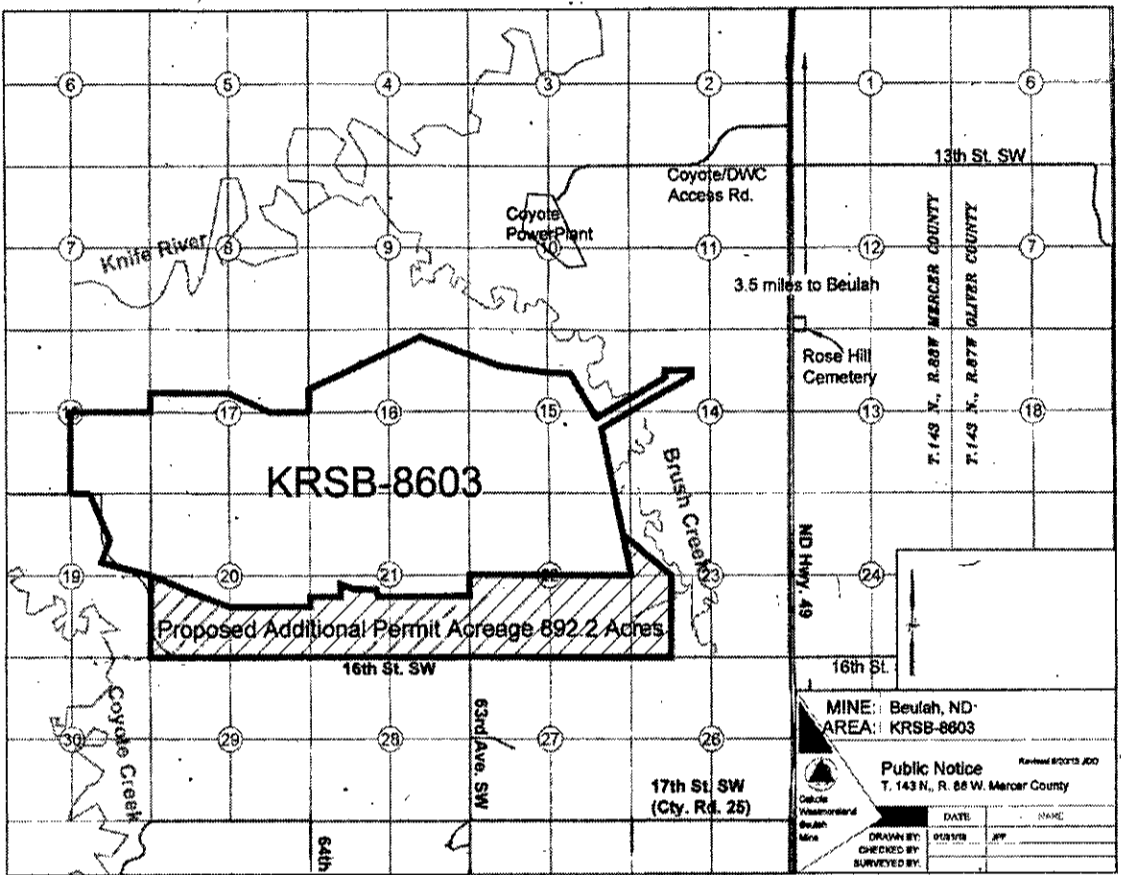
To file for the Rural area position, one must live outside of the city limits of Underwood or Riverdale.

NOTICE OF APPLICATION FOR REVISION TO A SURFACE COAL MINE PERMIT

Please take notice that Dakota Westmoreland Corporation, PO Box 39, Beulah, North Dakota 58523, has made application to the North Dakota Public Service Commission for Revision No. 27 to Surface Coal Mining Permit KRSB-8603. Revision No. 27 adds 892.2 acres in Sections 20, 21, 22 and 23, T.143N., R.88W, Mercer County, to the existing permit area for a total of 3558.3 acres for coal excavation and mining and associated disturbance activities in support thereof. The section line common to Sections 22 and 23, excluding the north 1,400 feet, Township 143 North, Range 88 West, Mercer County, North Dakota will be mined through.

The permit area is located in Sections 14, 15, 16, 17, 18, 19, 20, 21, 22 and 23, T.143N., R.88W., Mercer County, North Dakota. This area is contained on the United States geological survey map named Medicine Butte, N.E., North Dakota. The precise location and boundaries of the permit area are depicted on the accompanying map.
