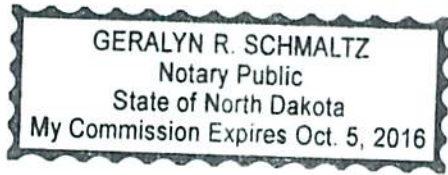

The Commission orders:




