NOTICE OF RECEIPT OF RENEWAL APPLICATION

March 13, 2013

BNI Coal, Ltd. has filed an application to renew Surface Coal Mining Permit No. BNCR-8106 covering lands located in:

Portions of Sections 23, 25, 35, and 36, T142N, R84W, and portions of Sections 31 and 32, T142N, R83W, Oliver County, totaling 1,223.80 acres.

This five-year permit renewal will allow the company to continue to operate under approved operation and reclamation plans until July 18, 2018. All coal has been removed from within the permit area, but some areas of the permit are currently being used to support mining activities in other permits. You may submit written comments or objections on the proposed permit renewal application and its effects on the environment and on surface owners of the land in the permit area. You may request an informal conference with the Commission and the applicant on the renewal application. The reasons for requesting an informal conference must be stated in the request. Written comments, objections, or requests for informal conference must be made by May 6, 2013.

If there is an informal conference, you may request a formal administrative hearing on the Commission ruling on the application. Your request for a formal hearing must be made within thirty days of the Commission ruling on the application.
