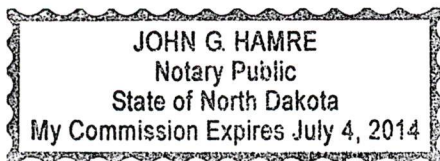

The price schedule pages specify switched access prices for a rate transition period through the year 2020.


On March 27, 2013 the Commission suspended the intrastate switched access price schedules filed in each of the cases enumerated above.

A **public hearing** on this matter will be held beginning **May 29, 2013 at 9:00 a.m.** in the Commission Hearing Room, State Capitol, 12th Floor, Bismarck, North Dakota 58505. The issue to be considered is whether the intrastate switched access price schedules filed by each of the companies in the cases enumerated above should be approved by the North Dakota Public Service Commission.
