Dear Mr. Nitschke:

In accordance with North Dakota Century Code Section 49-22-16.3(1), this letter is provided to notify the North Dakota Public Service Commission (“Commission”) that Hiland Crude, LLC (“Hiland”) intends to adjust the route of the Market Center Pipeline (PU-13-136) in one area located in Williams County. A route modification requiring authorization was previously requested in this area, and was approved by the Commission through Second Amended Findings of Fact, Conclusions of Law and Order dated February 25, 2015. An additional route adjustment is necessary under N.D.C.C. § 49-22-16.3(1), which requires no action by the Commission.

Enclosed for filing, please find an original and ten (10) copies of the following documents in support of Hiland’s route adjustment in accordance with N.D.C.C. § 49-22-16.3(1):

1. Certification of William E. Wolf;
2. Map depicting original route, previously approved route adjustment, and current route adjustment;
3. Class III Intensive Cultural Resource Inventory for the Addendum to Market Center II in Williams County, North Dakota prepared by Beaver Creek Archaeology, Inc. on behalf of Hiland;
4. Letter from the North Dakota State Historic Preservation Office concurring with “No Significant Sites Affected;” and
